TERMS & CONDITIONS FOR PARTICIPATION

Booking of Stalls: Booking of stalls will be made on receipt of the prescribed application form, duly completed, together with a bank draft towards 100% payment of the stall rent in favor of **Sky Media Pvt. Ltd.** (SMPL reserves the sole right for allotment of the stalls).

Applications received after the last date will be entertained only subject to availability of space.

The Sky Media Pvt. Ltd., reserves the right to alter the dimensions of the stalls without assigning any reason whatsoever and its decision regarding any matter related to fair shall be final and binding on the participants.

Each participant may therefore indicate the category (one only) in which he would like to be placed. The option once exercised shall be final and binding on the participant.

It shall be the responsibility of the participants to remove all exhibits, tools and other materials at the end of the fair and leave the stalls in the same condition in which these were allotted to them.

Possession / Vacation of Stalls: Participants will be given possession of the stalls one day before starting of fair from 8 a.m. The stalls shall be vacated latest by at the time of closing, failing which the Sky Media Pvt. Ltd. shall have the right to remove the exhibits/material at the risk and cost of the participants.

<u>Encroachment</u> of <u>Passages</u>: No encroachment or extension in the passages shall be allowed.

<u>Cleaning:</u> While Sky Media Pvt. Ltd. will arrange to carry out general cleaning, the participants shall be responsible for the cleanliness and tidiness of the stalls during the fair timings.

<u>Display of Banners, Posters etc.</u> There will be no restriction on the display of banners, posters etc., within a stall. However nothing will be allowed to be displayed outside the stall and above a height of 8 feet.

<u>Sale of Material</u>: Sale of any material will be permitted on the following conditions:

 Hawking and selling of material at specially reduced prices or above printed MRP shall be prohibited. No material prohibited by the law in India shall be exhibited or sold.

Playing Audio/Video Cassettes: Participants playing audio or video cassettes at the stalls should ensure that the level of sound does not cause any annoyance to either the neighbouring participants or to the visitors. The Sky Media Pvt. Ltd. will be the sole judge as to whether there is any annoyance to either the other participants or to the public.

Insurance: It will be the responsibility of the participants to insure their exhibits and stock against break-in, theft and damage by fire and water, any other unspecified reason during transit to and from the exhibition halls as well as during the duration of the Fair. The Sky Media Pvt. Ltd. will not bear any responsibility in this regard.

<u>Security:</u> While the Sky Media Pvt. Ltd. will make round the clock security arrangements of all the halls during the Fair. The Sky Media Pvt. Ltd. is not liable for the loss or damage to the goods and property of the participants during the Fair timings.

<u>Entry:</u> Participants will be allowed entry into the stall half an hours before opening time and shall vacate after 15 minutes of closing time every day. The participants will be given two entry passes per stall.

No goods or displays may be removed from the fair without written permission from the Sky Media Pvt. Ltd.

Repeal: In the event of a natural disaster or if circumstances so warrant, the Sky Media Pvt. Ltd. reserves the right to postpone, alter or cancel the Fair. In case the Fair is cancelled before the inauguration, rent collected shall be refunded after making the necessary deductions. However no refund will be made if a participant wishes to withdraw from the fair after making a booking.

Any of the terms and conditions mentioned above may be relaxed or modified at the sole discretion of the Management of Sky Media Pvt. Ltd. whose decision will be final and binding. All matters subject to the jurisdiction in the Jaipur only.

Stall Allotment

Application completed in all respects along with 100% advance payment before last date of booking will only be considered for allotment of stall. All payments should be drawn in the name of "Sky Media Pvt. Ltd.". Stall will be allotted to the company by name and no subletting will be allowed in any manner.
